5. Closure of Meeting

REPORT to UPGRADE COMMITTEE 9 March 2025

Since the last Project Manager report, the following items have taken place and are presented to the Community Centre Upgrade Committee Meeting on 12 March for consideration and acceptance:

Community Centre Kitchen Upgrade:

The five Solartube skylights have been installed through the external roof sheeting. The internal ceiling diffusers will be installed once the ceiling plasterboard sheeting has been completed.

The installation of the ceiling framework has been completed, however the lining cannot be installed until Metro Steel Services has completed the manufacture and installation of the rangehood canopy over the ovens. Metro needed to have the framework and wall linings up in order to do a final measure prior to manufacture.

At my last site visit it looked like the preparation work was being done for the relaying of the paving around the carpark end of the store room.

The contract completion date remains at 30 April 2025.

Community Centre Internal Amenities Upgrade:

Community Centre External Amenities Provision:
